  - : Only experienced and properly instructed persons should handle gases under pressure. The product must be handled in accordance with good industrial hygiene and safety procedures.

  - : Ensure the complete gas system was (or is regularly) checked for leaks before use.
- Safe handling of the gas receptacle** :
